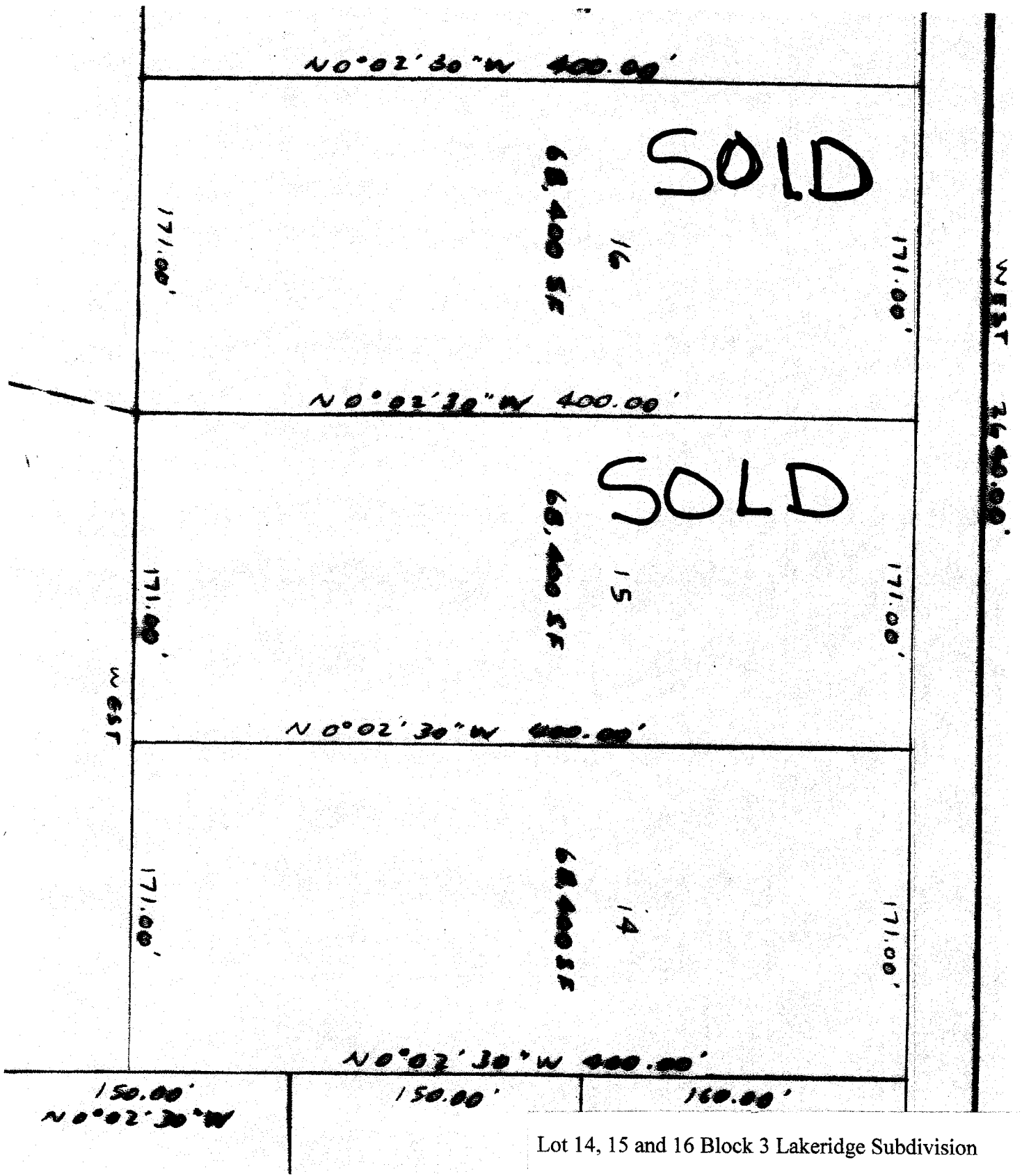
Lot 1, 2, 3 and 4 Block 3 Lakeridge Subdivision
